13.07 To discuss and approve the signing of MoU for Research Collaboration with various National/International Research Labs. / Institutes / Industry.

The Academic Council appreciated the proposed collaborations of the University with other institutions and approved of the positive steps taken towards the signing of MoU for Research Collaboration with various National/International Research Labs. / Institutes / Industry.

13.08 To consider the report presented by "Expert Committee" regarding generating conversion formula i.e. CGPA to percentage.

The Academic Council approved of the conversion formula presented by the Committee as per the following recommendations of the committee:

1. Regarding conversion of CGPA into percentage marks, the following formula shall be adopted for notional conversion of CGPA into percentage marks.
Formula : % Marks = (CGPA-0.75) x 10
2. The proposed conversion formula shall be applicable to all batches/programmes admitted in different Academic sessions of the University.

13.09 To approve the starting of programme of Bachelor in Vocational Studies B.VOC from School of Vocational Studies and Applied Sciences (SOVSAS) from Academic Session 2016-17.

The Academic Council approved of the starting of programme of Bachelor in Vocational Studies B.VOC from School of Vocational Studies and Applied Sciences (SOVSAS) from Academic Session 2016-17.

13.14 To discuss the appointment of retired faculty members on the positions of Assistant Professor, Associate Professor and Professor in various departments of the University on contractual basis.

The Academic Council approved the short term appointment of retired faculty members on the positions of Assistant Professor, Associate Professor and Professor in various departments of the University, on contractual basis.

The approved consolidated salary for such positions is as follows:

Assistant Professor	Rs 50,000/-
Associate Professor	Rs 70,000/-
Professor	Rs 90,000/-

13.15 To discuss the change of branch in B.Tech. programme after completion of first year.

The Academic Council approved the change of branch in B.Tech. programme after completion of first year as per following conditions:

1. Change of branch in the second year may be allowed against the vacant seats on the basis of merit at the B.Tech. first year examination for those who are pass without any carry over paper.
2. After change of branch, number of students in branch(s) shall neither increase over the intake approved by University nor it will decrease below 75% of intake approved by University
3. Change of branch facility is not applicable to following:-
 - (i) Candidates admitted in B.Tech. Biotech & Food Processing and Technology course.
 - (ii) Candidates admitted in second year of B.Tech. courses through Lateral entry.
4. The change of branch if allowed will become effective from B.Tech. IIIrd semester.
5. Further change of branch shall not be permitted.
