DETAILS OF THE DECISIONS TAKEN

09.01 Approval of minutes of the Eighth Academic Council meeting held on 27th April 2011

09.02 To inform the Academic Council of the actions taken on the decisions of the Eighth Academic Council meeting

The Academic Council was informed of the actions taken on the decisions of its Eighth meeting held on 27th April, 2011. The council took note of Actions Taken with the following observations:

- The council was apprised that the Design and Art work of the magazine is in progress. The draft of the same is ready and it will be published soon.
- Regarding the launching of Executive M.B.A (15 months duration), the council suggested to pursue with the UGC for a written reply and apprise the council of the position in the next meeting.

09.04 To apprise the Academic Council about the Proceedings of 'Board of Studies' and discuss and approve the proposed New Courses in various Schools.

The Academic Council took notice of the details of minutes of the Board of Studies of each School.

- School of Buddhist Studies and Civilization: The minutes were approved by the Council.
- School of Law, Justice and Governance: The minutes were discussed by the members and approved with the following observations
 - (i) An optional paper comprising of DNA, DNA fingerprinting and Forensic labs may be included in the syllabus.
- School of Management: The minutes were approved by the Council.

- School of Engineering: The minutes were approved by the Council.
- School of Information & Communication Technology: The proposal for the launch of the new course in MCA 3 years in the School was discussed and following suggestions were made by the members
 - (i) M.C.A. with specific emphasis in different specializations may be prepared and it should again be placed in the next Academic Council meeting.
- School of Humanities & Social Sciences: The minutes were approved by the Council.
- School of Biotechnology: The minutes were approved by the Council.
- School of Vocational Studies and Applied Sciences: As per the discussion by the Council members it was suggested that the renowned companies dealing with herbal/medicinal products, should be contacted so as to explore future possibilities regarding internship and employability of our students. Further it was suggested that the experts from Universities like Banaras Hindu University, Jaipur Ayurvedic University, Ayurvedic University in Uttranchal, Jamia Hamdard, Tibiya College of Aligarh Muslim University etc. may be contacted for further guidance and suggestions for the following two courses:
 - a. Cultivation, Collection & processing of Medicinal plants
 - **b.** Standardization and Quality Control of Phytopharmaceuticals May be sent to experts of

During discussion the Council strongly suggested to create two cells in the University, which are made mandatory as per UGC guidelines, and provision of special grants is provided, for establishing these cells.

(i) CELL FOR EQUAL OPPORTUNITY: The Cell is to be created in the University to safeguard the rights of university students/staff to have equal opportunity. Emphasis to the disadvantaged groups for learning and creating space for them to mainstream themselves will be the job of equal opportunity cell which will run specific scheme of coaching for SCs, STs, women, OBC (non-creamy layer), minorities and physically challenged persons in order to remove social inequalities that created the barriers of denial of access to materials, cultural and educational resources to the disadvantaged groups of society.

(ii) CELL FOR ACTION AGAINST SEXUAL HARESSMENT

09.05 To apprise the Academic Council about the students going for Semester Abroad programme to a foreign University.

The council appreciated the initiative of the government of Uttar Pradesh which has introduced special scholarships for students of SC/ST and other economically challenged students across all classes of the society for studying one semester at a foreign university. The Council applauded that the University is in the process of formalizing tie ups and mutual accreditations with many universities in UK, France, Finland, Netherlands, Australia, Denmark and USA.

09.06 To apprise the Academic Council about the admission in Ph. D Programme of each School.

The Council appreciated the enrollment of 79 scholars in the University in the Academic Session (Odd Semester 2011-2012) .The Council also proposed that an exhaustive list of subject experts, who have proved themselves above board from all over the country, must be compiled and while a thesis is examined or evaluated an examiner must come from the same list.

09.07 To discuss and approve the modifications in the Ordinances of the University.

The Council approved of the Mid-Term Examination and Research related minutes of the meeting.

The Council proposed that a **Review Committee** should be comprised so as to analyze, assess and evaluate the medical applications of students who could not appear in the Mid-Term examination due to medical emergency.

The committee which will review the medical related matters will comprise of

- (iv) Doctor or Representative of CMO

The other discipline related matters will be dealt by the Chief Proctor and the concerned team members. A suggestion to depute a Security officer under the Chief proctor was also presented by the Council.

09.08 To apprise the Academic Council about the modifications in the names of the Centres of Excellence / Departments under Schools of Studies.

09.09 To apprise the Academic Council about the eligibility criteria of a Research Supervisor/Guide.

The Council approved that the Guidelines of UGC must be adhered and followed.

09.10 Any other matter with the permission of the Chair

The Council suggested that an Ethics Committee should be constituted in the University and any person who is writing a project for International/ National grants or interviewing humans or is collecting social data should get the approval/clearance of/from the Ethics Committee before presenting to external bodies. It was proposed by the Council that the precedence of other renowned Universities to be studied before constitution of this committee.

• A committee to review the Fee structure of all the programmes in the Schools of the University was constituted. The members of the same are as follows:

Fee Structure Review Committee for Academic and Hostel Fee

It was decided that the fee structure of the University must conform to the regulations of UGC and review and revise the Academic and Hostel fee (for General and Socially challenged students) and present the minutes of the same in next Academic Council meeting.

- The Dean(I/c), Student Affairs proposed an Award of Excellence for the Students of the University
- (i) Chancellor's Gold Medal Award: This Gold medal may be awarded to the student/s academically best i.e. the topper/s overall. The student should score the highest CGPA in the respective discipline. The award will carry a Chancellor's Gold Medal, Rs. 15,000 (Fifteen Thousand), and citation certificate by the Honorable Vice-Chancellor, Dean of Students Affairs, and Dean of School.
- (ii) Semester Topper Award: This award may be given to the students who secure FIRST position in a particular semester in their respective courses. The award may be for Rs. 10,000 (Ten Thousand) with citation certificate. This award may work as a big boost to the students and encourage them to engage more in regular academic activities and pursuits.

The council approved the same.
